Uganda's Military High Command Incapacitated By ICC

Last updated : 15 Jul 2008, Kampala

Since its establishment in 2002, much of the international community has been waiting in anticipation to see if the International Criminal Court (ICC) will have the force of authority to prosecute alleged criminals as required. Within the short period, the ICC has made its presence known, some investigations have been conducted and prosecutions are beginning. Already the ICC's actions are beginning to bear positive albeit unintended benefits.

To date the international court has carried out investigations on crimes against humanity within the East Central African great lakes region. In fact about a dozen public arrest warrants and numerous sealed arrest warrants have been issued and some suspects have been arrested.

However, the recent arrest of a suspect that was in a sealed warrant has given many of Africa's 'big men' and their sycophants sleepless nights. Its only recently that these continental misfits have realised the dangers of a sealed warrant. Many of them know they have committed crimes against their citizens and are wondering if their arrest warrant could also be sealed. This is especially so in countries like Rwanda, Uganda, Democratic Republic of Congo, Sudan and the Central African Republic (CAR).

The recent daring arrest of Jean-Pierre Bemba Gombo, President and Commander in Chief of the Mouvement de libération du Congo (MLC), by the Belgian authorities following a sealed warrant of arrest has left the senior echelons of the Ugandan military in disarray.

Ugandan senior military officers have reason to worry. Jean-Pierre Bemba is accused of being criminally responsible for war crimes and crimes against humanity committed in the Central African Republic.

It was the Ugandan Peoples Defence Force (UPDF) with the acquiescence of Lt. General Yoweri Museveni that made Jean-Pierre Bemba an agent of doom and provided him with military training to execute the devilish agenda far and wide. It was the same UPDF officers that trained recruits of the Mouvement de libération du Congo and then issued them with military hardware that was used to commit crimes against humanity in CAR.

Individual top army commanders also profited tremendously through trafficking of military hardware to MLC and other competing rebel groups within the DRC.

It is very telling that the kind of war crimes alleged to have been committed by Bemba in CAR, i.e rape, torture, disfigurement, humiliating and degrading treatment , and pillaging of whole villages are identical to what the UPDF has been doing in northern Uganda and the Sudan over the last 20 years - It was the case of the student imitating the teacher.

Investigations have revealed that among the still outstanding sealed arrest warrant are a number of senior Ugandan military officers. They are wanted for being either an accomplice, aiding and abetting, inchoate offenses or simply persons of interest.

These officers include: Major General Salim Saleh, Major General James Kazini, Major Muhoozi Kainerugaba, Major General Kahinda Otafiire, Major General David Tinyefuza, General Aronda Nyakairima, Col. Mugeni, Col, Tinkamanyire, Col. Peter Kerim, Col. Kyakabale and Col. Leo Kyanda.

It is believed arrest warrants for these officers were sealed because of their military background and likelihood of flight should they get wind of what is afoot. It has been established as well that Interpol and immigration offices in North America, Europe, and select countries in Asia and Africa where these officers are known to frequent have received "notifications". Belgium is the one country, which has it written in statute to arrest these international criminals under their municipal law while all the others have agreed to do the same under international treaty. Now it is not only Belgium the crooks fear visiting rather they fear that they could be arrested anywhere. As the saying goes the pressure is now on them how to avoid going to the countries where they are hiding their loot?

Slowing the effort to capture them is the fact that some of these officers are known to use aliases when travelling out of Uganda. Recently two senior officers narrowly missed being captured by Interpol. One was in Nairobi but was using an alias that helped him survive, and the other was in Johannesburg also travelling on an alias.

Interpol is however now aware of this, and it is a matter of time before they will be apprehended.

Effectively, the ICC has incapacitated Uganda's military high command.

Letter to the British House Commons

Chemical Weapons, Money Laundering, Drugs, Mafioso Dealings: The link between M7 and Global Terrorism

Dear Members of the British House Commons,

I am a Ugandan Citizen and by default a Citizen of the Commonwealth. I wish to call for an investigation of the following facts and the connection between the different incidents that may be a major factor in the death of British soldiers in Afghanistan.

(a) For about six years Uganda has been established as a conduit for drugs with several Ugandan citizens having been arrested and locked up in different countries including China and the United Kingdom. The drug cartel operates between Afghanistan, Pakistan, Uganda, Nigeria, UK and other destinations and counts in its ranks the most influential people in Uganda especially from Uganda's first family.

(b) Last year a personal assistant (employee) of Major General Caleb Akandwanaho, (Salim Saleh, who is also a Junior Minister in his brother Yoweri Museveni's cabinet) was arrested in the UK. She was linked to an international drug ring and traveling on a Ugandan Diplomatic Passport. The Uganda High Commission in London and President Museveni's personal legal team were dispatched immediately to secure her release and coach her to lie in a bid to defeat the course of justice. Her Majesty's Courts prevailed and Rose Birungi was handed a 15 year prison sentence but without revealing her connections and Godfather.

(c) Five years ago one Hassan Bassajabalaba was briefly detained in Italy on a drugs case. Hassan is a front man for President Museveni. He was rescued from jail after only three days. His business empire in hides and skins exports could not however survive without revenue from the drugs. President Museveni personally ordered that a total of USD 20 Million be handed over by the Bank of Uganda to Hassan to rescue the crumbling businesses.

(d) In March 2008 one Viktor Bout a dubious arms dealer was arrested in the Far East. Mr Bout was one of the major importers of illegal arms and military hardware into the Great Lakes Region. He had close connections with President Museveni and his Brother Salim Saleh and they were using Uganda end-user license to supply arms to Congolese including Rubanga and Jean-Pierre Bemba who have since been arrested and hauled before the International Courts for gross violations of human rights and war crimes.

(f) President Museveni's Adviser Mr. Ananias Tumukunde has been making a series of journeys to various European countries and dealing with companies that among others items deal with chemical weapons. He too uses a Ugandan Diplomatic passport. That was until Her Majesty the Queens Government, arrested him last April with over USD 100,000 cash. President Museveni sent his official Legal adviser Mr. Fox Odoi and the High Commissioner among others to oversee the rescue effort of this suspect from British justice.

I call upon the British House of Commons to institute two independent investigative teams to find out the links between President Museveni, His Brother Salim Saleh, their top business associates of Asian origin in Kampala and their actual links to the global crimes of promoting terror, trading in drugs and supplying terrorists with illicit arms. Two teams are necessary as President Museveni and his cartel can easily compromise any one team. These teams should as much as is possible, not, repeat NOT work with the British High Commission in Kampala.

Please note, Museveni and team who financed, armed and presided over the militias that have since the mid-1990s led to mayhem in North Eastern Congo will have no qualms whatsoever dealing in drugs, arms, chemical weapons etc, even if it means dealing with outlaws and terrorists such as the Taliban in Afghanistan, Pakistan and elsewhere.

Please, please investigate this man. Museveni prefers to posture as one of the strong people in the war against terror. But those of us that know him better, are aware that at best this is a smoke screen for more sinister acts over and beyond unleashing undemocratic means to retain power which you are all aware of.

### Senior Rwandan official arrested

Ms Kabuye has heroic status in Rwanda as an MP and former guerrilla

German police have arrested a senior Rwandan official in connection with the killing of a former president whose death triggered the 1994 genocide.

Rose Kabuye - the chief of protocol for current Rwandan President Paul Kagame - was detained on arrival at Frankfurt on a warrant issued by a French judge.

She is one of nine senior Rwandan officials wanted over the shooting down of Juvenal Habyarimana's plane.

All are members of the party which ousted the genocidal regime.

Correspondents say Ms Kabuye, a former guerrilla fighter with the Rwandan Patriotic Front (RPF), now Rwanda's ruling party, has heroic status in Rwanda.

She has since served as an MP and mayor of the capital Kigali, and is one of President Kagame's closest aides.

Transfer to France

A German diplomat told AFP news agency that Ms Kabuye had been in Germany on private business and that Germany was "bound to arrest her" by a French-issued European arrest warrant.

Ms Kabuye has visited the country before but under German law could not be arrested as she was part of an official delegation.

The government denies involvement in the death of the former president

"Rwanda has been made aware on several recent occasions that if Ms Kabuye returned to Germany she would be arrested," said the diplomat.

Ms Kabuye's lawyer said she would be transferred to France "as quickly as possible".

"She is ready to speak to the judges, especially since, to our knowledge, there isn't much in the dossier," said Leon-Lef Forster, referring to the evidence against his client.

AFP quoted Rwandan Information Minister Louise Mushikiwabo as saying that Ms Kabuye's arrest was a "misuse of international jurisdiction".

Complicity

Ms Kabuye and the eight other senior RPF officials were indicted in France in 2006 following an investigation.

The BBC's Alasdair Sandford in Paris says the charge led to an immediate break in diplomatic relations between Paris and Kigali which has continued ever since.

Although the RPF is suspected of being behind the attack on the former president's plane, their involvement has never been proved and they have rejected the charges.

Rwandan President Paul Kagame has also accused France of complicity in the genocide, in which 800,000 Rwandans were killed.

Earlier this year, Ms Kabuye's lawyers complained that they were being denied access to the indictment dossier, and criticised what they described as France's "silence" over the case, says our correspondent.

The African Union (AU) has said arrest warrants would not be recognised in AU countries and has also accused France of violating international law by failing to bring the case to trial.
